Article 6

District Regulations ("PS")

#### Section 6.15 "(PS") Public Service Districts

The following regulations shall apply to all "PS" Public Service Municipal Training Districts:

- 1. Uses permitted.SES PERMITTED: No structure of part thereof shall be erected, altered, or used and no land shall be used, and no land shall be used except for one or more of the following purposes:
  - a. Fire Department Training Grounds, training tower, live fire and pumping operation concrete pad, classroom (subject to regulation of Article 9 section 9.19).
  - b. Department of Public Works facilities
  - c. Police Department Gun Range (subject to regulation of Article 9 section 9.19), classroom.
  - d. Other uses
    - Art galleries
    - · Planned Unit Development (Subject to provisions of Section 9.14)
    - Public Education Nature Center
    - Public Libraries
    - Public Museums
    - Public Park, golf courses, tennis courts, and similar sports recreational uses (Subject to provisions of Section 9.15)
- 1.2. <u>Conditional Uses Permitted.</u>: <u>Conditional uses permitted.</u> Structures and parts thereof may be erected, altered, or used, and land may be used for one or more of the following purposes subject to the approval of the city planning commission and subject to the conditional use provisions of Article 8.
  - a. Restaurants (No Drive Thru Service).
